Plus linked to iShares MSCI EAFE Index Fund

Description

Barclays issued \$8.74 million of Plus linked to iShares MSCI EAFE Index Fund on March 4, 2013 at \$10 per note.

These notes are Barclays-branded PLUS securities that do not pay periodic coupons, but instead pay a single amount at maturity depending on iShares MSCI EAFE Index Fund's share price at maturity.


If iShares MSCI EAFE Index Fund's share price on April 1, 2014 is higher than \$58.27, but lower than \$61.26, the notes pay a return equal to the percentage increase in iShares MSCI EAFE Index Fund multiplied by 3.0. If on April 1, 2014 iShares MSCI EAFE Index Fund's share price is above the \$61.26, the notes pay the maximum payout of \$11.54. If on April 1, 2014 iShares MSCI EAFE Index Fund's share price is below \$58.27, investors receive the face value per note reduced by the percentage decline in the reference asset. The notes will pay nothing at maturity if the reference asset declines to zero.

Valuation

This note can be valued as a combination of a note from Barclays, a short at-the-money put option, three long at-the-money call options, and three short out-of-the-money call options. The short at-the-money put option exposes investors to any decline in iShares MSCI EAFE Index Fund. The three short out-of-the-money call options has the strike price of \$61.26, and limits the maximum return of the notes beyond the cap level. For reasonable valuation inputs this note was worth \$9.48 when it was issued on March 4, 2013 because the value of the options investors gave Barclays plus the interest investors would have received on Barclays's straight debt was worth \$0.52 more than the call options investors received from Barclays.

There is no active secondary market for most structured products. Structured products, including this note, therefore are much less liquid than simple stocks, bonds, notes and mutual funds. Investors are likely to receive less than the structured product's estimated market value if they try to sell the structured product prior to maturity. Our valuations do not incorporate this relative lack of liquidity and therefore should be considered an upper bound on the value of the structured product.

Payoff Curve at Maturity



The payoff diagram shows the final payoff of this note given iSbares MSCI EAFE Index Fund's share price (horizontal axis). For comparison, the dashed line shows the payoff if you invested in iSbares MSCI EAFE Index Fund directly.



Maturity Payoff Diagram




Analysis


This Plus pays investors the increase in iShares MSCI EAFE Index Fund multiplied by 3.0 capped at 15.40%, but if iShares MSCI EAFE Index Fund declines over the term of the note, investors will suffer losses equal to the percentage decline in iShares MSCI EAFE Index Fund. In addition, investors bear the credit risk of Barclays. Investors purchasing this Plus effectively sell at-the-money put and out-of-the-money call options to Barclays, buy at-the-money call options, and a zero-coupon note from Barclays. This Plus is fairly priced if and only if the market value of the options investors gave Barclays plus the interest investors would have received on Barclays's straight debt.

Barclays's Stock Price




The graph above shows the adjusted closing price of the issuer Barclays for the past several years. The stock price of the issuer is an indication of the financial strength of Barclays. The adjusted price shown above incorporates any stock split, reverse stock split, etc.





Credit default swap (CDS) rates are the market price that investors require to bear credit risk of an issuer such as Barclays. CDS rates are usually given in basis points (bps). One basis point equals 0.01%. Higher CDS rates reflect higher perceived credit risk, higher required yields, and therefore lower market value of Barclays's debt, including outstanding Plus. Fluctuations in Barclays's CDS rate impact the market value of the notes in the secondary market.




iShares MSCI EAFE Index Fund's Share Price

The graph above shows the historical levels of iShares MSCI EAFE Index Fund for the past several years. The final payoff of this note is determined by iShares MSCI EAFE Index Fund's share price at maturity. Higher fluctuations in iShares MSCI EAFE Index Fund's share price correspond to a greater uncertainty in the final payout of this Plus.

Realized Payoff



Reference Asset iShares MSCI EAFE Index Fund's Implied Volatility



The annualized implied volatility of iShares MSCI EAFE Index Fund on February 27, 2013 was 18.68%, meaning that options contracts on iShares MSCI EAFE Index Fund were trading at prices that reflect an expected annual volatility of 18.68%. The higher the implied volatility, the larger the expected fluctuations of iShares MSCI EAFE Index Fund's share price and of the Note's market value during the life of the Notes.

Decomposition of this Plus



This note can be decomposed into different components, and each component can be valued separately. The chart above shows the value of each component of this Plus.

- Delta measures the sensitivity of the price of the note to the iShares MSCI EAFE Index Fund's share price on February 27, 2013.
 CDS rates can be considered a measure of the probability that an issuer will default over a certain period of time and the likely loss given a default. The lower the CDS rate, the lower the default probability. CDS rate is given in basis points (1 basis point equals 0.01%), and is considered as a market premium, on top of the risk-free rate, that investors require to insure against a potential default.
 Fair price evaluation is based on the Black-Scholes model of the iShares MSCI EAFE Index Fund on February 27, 2013.
 Calculated payout at maturity is only an approximation, and may differ from actual payouts at maturity.
