Reverse Exchangeable Note linked to MBIA Inc.

Description

JPMorgan issued \$520,000 of Reverse Exchangeable Note linked to MBIA Inc. on January 24, 2011 at \$1,000 per note.

These notes are JPMorgan-branded reverse convertibles. Reverse convertibles pay periodic interest coupons and at maturity convert into shares of the reference security if the price of the reference stock at the notes' maturity is below its price when the notes were issued and had closed below a specified "trigger" during the term of the notes.

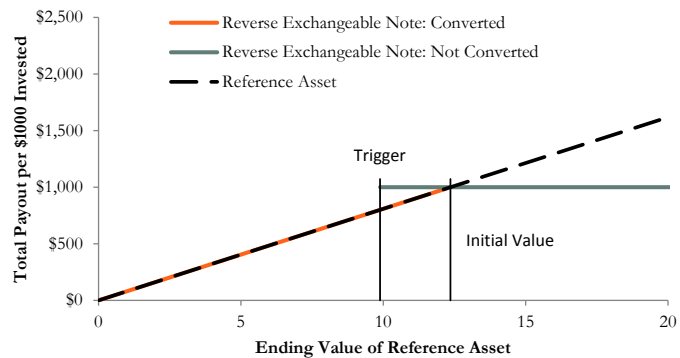
These 3-month notes pay monthly coupons at an annualized rate of 29.00%. In addition to the monthly coupons, at maturity on April 25, 2011 investors will receive the market value of 80.91 shares of MBIA Inc.'s stock if on April 19, 2011 MBIA Inc.'s stock price closes below \$12.36 (MBIA Inc.'s stock price on January 19, 2011) and had ever closed at or below \$9.89 during the term of the notes. Otherwise, investors will receive the \$1,000 face value per note.

Valuation

This JPMorgan reverse convertible linked to MBIA Inc.'s stock can be valued as a combination of a note from JPMorgan and a short down-and-in, at-the-money put option on MBIA Inc.'s stock. For reasonable valuation inputs this note was worth \$945.12 per \$1,000 when it was issued on January 24, 2011 because investors were effectively being paid only \$71.25 for giving JPMorgan an option which was worth \$126.13.

There is no active secondary market for most structured products. Structured products, including this note, therefore are much less liquid than simple stocks, bonds, notes and mutual funds. Investors are likely to receive less than the structured product's estimated market value if they try to sell the structured product prior to maturity. Our valuations do not incorporate this relative lack of liquidity and therefore should be considered an upper bound on the value of the structured product.

Payoff Curve at Maturity



The payoff diagram shows the final payoff of this note given MBIA Inc.'s stock price (horizontal axis). For comparison, the dashed line shows the payoff if you invested in MBIA Inc.'s stock directly.

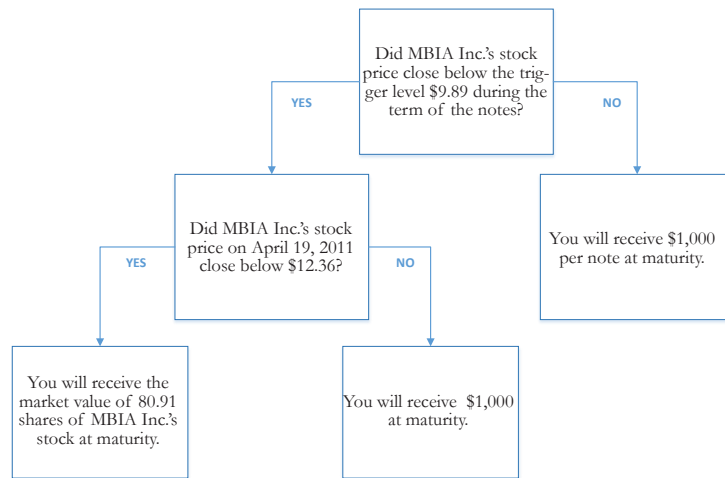

Maturity Payoff Diagram



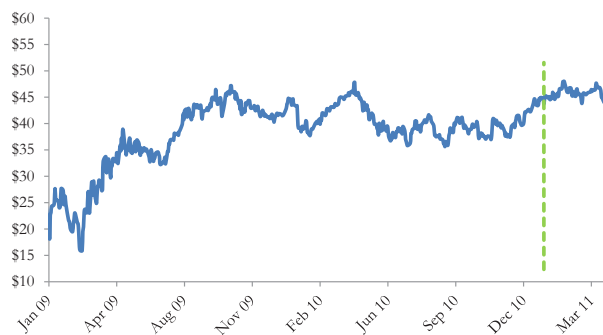
The contingent payoffs of this Reverse Exchangeable Note.

Analysis

This reverse convertible's 29.00% coupon rate is higher than the yield JPMorgan paid on its straight debt but, in addition to JPMorgan's credit risk, investors bear the risk that they will receive shares of MBIA Inc.'s stock when they are worth substantially less than the face value of the note at maturity.

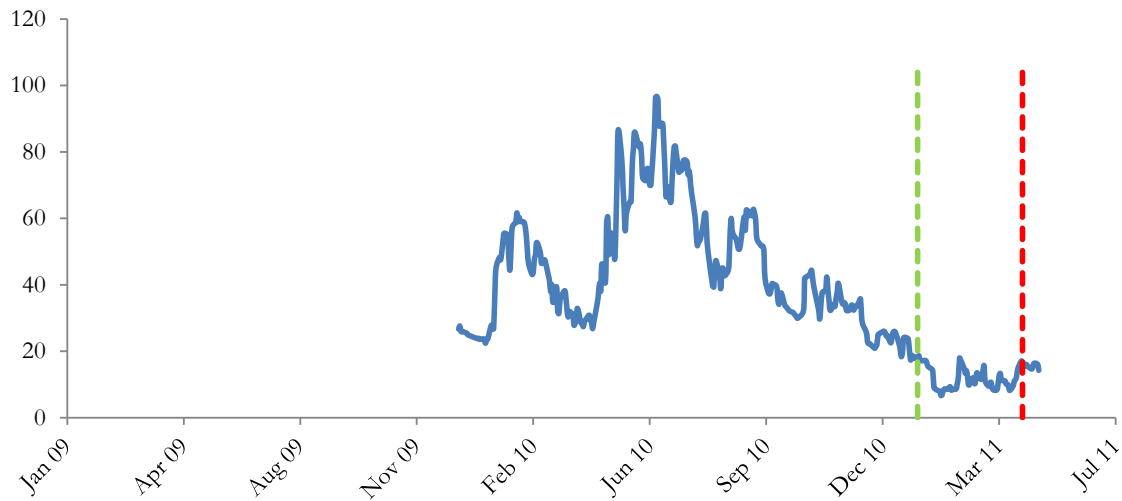
Investors purchasing reverse convertibles effectively sell put options to JPMorgan and post the note's issue price as collateral to secure satisfaction of the investors' obligations under the option contracts. JPMorgan pays investors a "coupon" that is part payment for the put options and part interest on the investors' posted collateral. This reverse convertible is fairly priced if and only if the excess of the reverse convertible's "coupon rate" above the interest JPMorgan pays on its straight debt equals the value of the put option investors are giving to JPMorgan. Whether the reverse convertible is suitable or not is equivalent to whether selling put options on the reference stock at the option premium being paid by JPMorgan was suitable for the investor.

JPMorgan's Stock Price



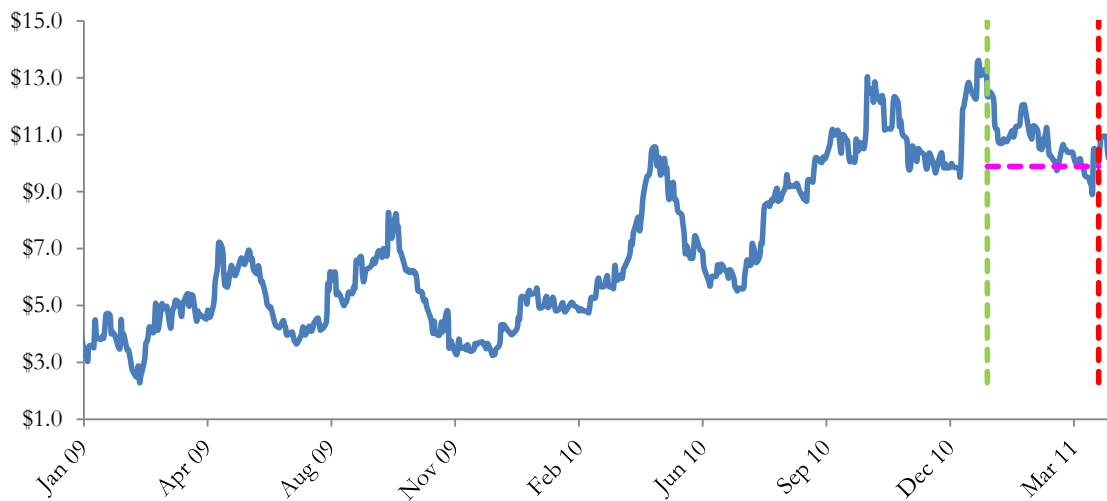
The graph above shows the adjusted closing price of the issuer JPMorgan for the past several years. The stock price of the issuer is an indication of the financial strength of JPMorgan. The adjusted price shown above incorporates any stock split, reverse stock split, etc.

JPMorgan's CDS Rate



Credit default swap (CDS) rates are the market price that investors require to bear credit risk of an issuer such as JPMorgan. CDS rates are usually given in basis points (bps). One basis point equals 0.01%. Higher CDS rates reflect higher perceived credit risk, higher required yields, and therefore lower market value of JPMorgan's debt, including outstanding Reverse Exchangeable Note. Fluctuations in JPMorgan's CDS rate impact the market value of the notes in the secondary market.

MBIA Inc.'s Stock Price

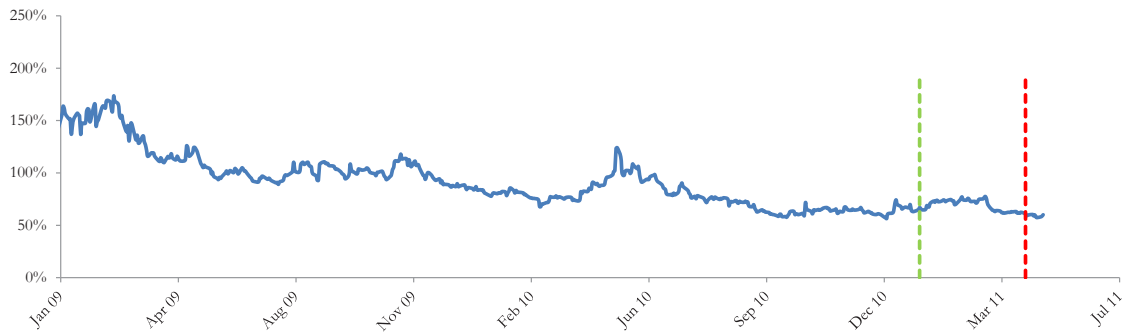


The graph above shows the historical levels of MBIA Inc.'s stock for the past several years. The final payoff of this note is determined by MBIA Inc.'s stock price at maturity. Higher fluctuations in MBIA Inc.'s stock price correspond to a greater uncertainty in the final payout of this Reverse Exchangeable Note.

Realized Payoff

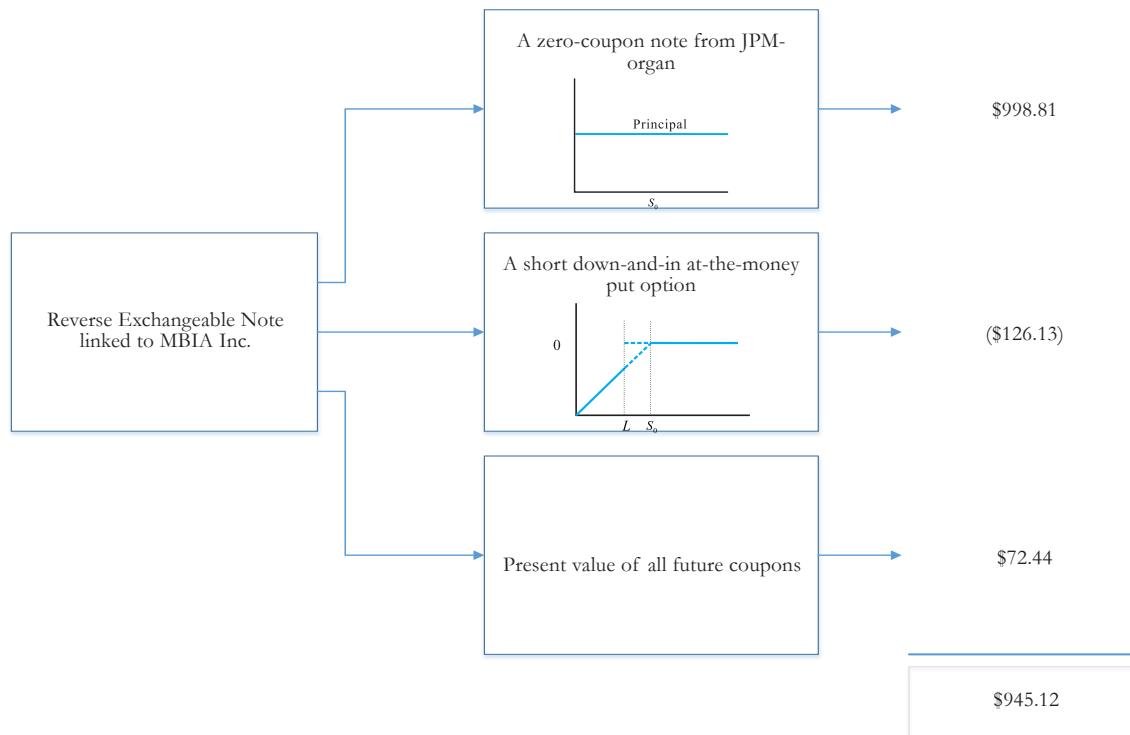
This note matured on April 25, 2011 and investors received \$810.67 per note (or equal to the value of 80.91 shares of MBIA Inc. stock's closing price on April 19, 2011).

Reference Asset MBIA Inc.'s Stock's Implied Volatility



The annualized implied volatility of MBIA Inc.'s stock on January 19, 2011 was 67.00%, meaning that options contracts on MBIA Inc.'s stock were trading at prices that reflect an expected annual volatility of 67.00%. The higher the implied volatility, the larger the expected fluctuations of MBIA Inc.'s stock price and of the Note's market value during the life of the Notes.

Decomposition of this Reverse Exchangeable Note



This note can be decomposed into different components, and each component can be valued separately. The chart above shows the value of each component of this Reverse Exchangeable Note.

1. Delta measures the sensitivity of the price of the note to the MBIA Inc.'s stock price on January 19, 2011.
2. CDS rates can be considered a measure of the probability that an issuer will default over a certain period of time and the likely loss given a default. The lower the CDS rate, the lower the default probability. CDS rate is given in basis points (1 basis point equals 0.01%), and is considered as a market premium, on top of the risk-free rate, that investors require to insure against a potential default.
3. Fair price evaluation is based on the Black-Scholes model of the MBIA Inc.'s stock on January 19, 2011.
4. Calculated payout at maturity is only an approximation, and may differ from actual payouts at maturity.
5. Our evaluation does not include any transaction fees, broker commissions, or liquidity discounts on the notes.
