# Trigger Yield Optimization Notes linked to E.I. du Pont de Nemours and Company

# Description

Royal Bank of Canada issued \$5.70 million of Trigger Yield Optimization Notes linked to E.I. du Pont de Nemours and Company on September 28, 2011 at \$40.46 per note.

These notes are Royal Bank of Canada-branded single observation reverse convertibles. Single observation reverse convertibles pay periodic interest coupons and at maturity convert into shares of the reference security if the price of the reference security at the notes' maturity is below the trigger price determined when the notes were issued.


These 6-month notes pay monthly coupons at an annualized rate of 7.37%. In addition to the monthly coupons, on March 29, 2012 investors will receive the market value of one share of E.I. du Pont de Nemours and Company's stock if on March 23, 2012 E.I. du Pont de Nemours and Company's stock closes below \$32.37 (80% of E.I. du Pont de Nemours and Company's stock price on September 23, 2011). Otherwise, investors will receive the \$40.46 face value per note.

## Valuation

This Royal Bank of Canada single observation reverse convertible linked to E.I. du Pont de Nemours and Company's stock can be valued as a combination of a note from Royal Bank of Canada and a short European out-of-the-money cash-or-nothing binary put option, and a short European out-of-the-money put option on E.I. du Pont de Nemours and Company's stock. For reasonable valuation inputs this note was worth \$37.92 per \$40.46 when it was issued on September 28, 2011 because investors were effectively being paid only \$1.20 for giving Royal Bank of Canada options which were worth \$3.73.

There is no active secondary market for most structured products. Structured products, including this note, therefore are much less liquid than simple stocks, bonds, notes and mutual funds. Investors are likely to receive less than the structured product's estimated market value if they try to sell the structured product prior to maturity. Our valuations do not incorporate this relative lack of liquidity and therefore should be considered an upper bound on the value of the structured product.

#### Payoff Curve at Maturity



The payoff diagram shows the final payoff of this note given E.I. du Pont de Nemours and Company's stock price (horizontal axis). For comparison, the dashed line shows the payoff if you invested in E.I. du Pont de Nemours and Company's stock directly.



#### Maturity Payoff Diagram




The contingent payoffs of this Trigger Yield Optimization Note.

### Analysis

This single observation reverse convertible's 7.37% coupon rate is higher than the yield Royal Bank of Canada paid on its straight debt but, in addition to Royal Bank of Canada's credit risk, investors bear the risk that they will receive shares of E.I. du Pont de Nemours and Company's stock when those shares are worth substantially less than the face value of the note at maturity.

Investors purchasing these reverse convertibles effectively sell put options to Royal Bank of Canada and post the note's issue price as collateral to secure satisfaction of the investors' obligations under the option contracts. Royal Bank of Canada pays investors a "coupon" that is part payment for the put options and part interest on the investors' posted collateral. This reverse convertible is fairly priced if and only if the difference between the reverse convertible's "coupon rate" and interest paid on Royal Bank of Canada's straight debt equals the value of the put option investors are giving to Royal Bank of Canada. Whether this reverse convertible is suitable or not is identically equivalent to whether selling put options on the reference stock at the option premium being paid by Royal Bank of Canada was suitable for the investor.

#### Royal Bank of Canada's Stock Price





The graph above shows the adjusted closing price of the issuer Royal Bank of Canada for the past several years. The stock price of the issuer is an indication of the financial strength of Royal Bank of Canada. The adjusted price shown above incorporates any stock split, reverse stock split, etc.

#### Royal Bank of Canada's CDS Rate



Credit default swap (CDS) rates are the market price that investors require to bear credit risk of an issuer such as Royal Bank of Canada. CDS rates are usually given in basis points (bps). One basis point equals 0.01%. Higher CDS rates reflect bigher perceived credit risk, bigher required yields, and therefore lower market value of Royal Bank of Canada's debt, including outstanding Trigger Yield Optimization Note. Fluctuations in Royal Bank of Canada's CDS rate impact the market value of the notes in the secondary market.







The graph above shows the historical levels of E.I. du Pont de Nemours and Company's stock for the past several years. The final payoff of this note is determined by E.I. du Pont de Nemours and Company's stock price at maturity. Higher fluctuations in E.I. du Pont de Nemours and Company's stock price correspond to a greater uncertainty in the final payout of this Trigger Yield Optimization Note.

#### **Realized Payoff**


This note matured on March 29, 2012 and investors received \$40.46 per note.





The annualized implied volatility of E.I. du Pont de Nemours and Company's stock on September 23, 2011 was 40.72%, meaning that options contracts on E.I. du Pont de Nemours and Company's stock were trading at prices that reflect an expected annual volatility of 40.72%. The higher the implied volatility, the larger the expected fluctuations of E.I. du Pont de Nemours and Company's stock price and of the Note's market value during the life of the Notes.

#### Decomposition of this Trigger Yield Optimization Note



This note can be decomposed into different components, and each component can be valued separately. The chart above shows the value of each component of this Trigger Yield Optimization Note.

- Delta measures the sensitivity of the price of the note to the E.I. du Pont de Nemours and Company's stock price on September 23, 2011.
  CDS rates can be considered a measure of the probability that an issuer will default over a certain period of time and the likely loss given a default. The lower the CDS rate, the lower the default probability. CDS rate is given in basis points (1 basis point equals 0.01%), and is considered as a market premium, on top of the risk-free rate, that investors require to insure against a potential default.
  Fair price evaluation is based on the Black-Scholes model of the E.I. du Pont de Nemours and Company's stock on September 23, 2011.
  Calculated payout at maturity is only an approximation, and may differ from actual payouts at maturity.
