Trigger Phoenix Autocallable Optimization Securities linked to JPMorgan

Description

UBS issued \$125,000 of Trigger Phoenix Autocallable Optimization Securities linked to JPMorgan on November 30, 2012 at \$10 per note.

Structured Products Research Report


These 12-month notes are UBS-branded reverse convertible notes. On the quarterly coupon observation date, if the notes are not called back, they pay either quarterly coupon at an annualized rate of 9.42% if JPMorgan's stock price closes above the coupon barrier \$32.60, or no coupon if the stock price closes below the barrier. The first coupon observation date is February 27, 2013. This autocallable notes will be called back if the reference stock price on any quarterly call observation date after February 27, 2013 exceeds the initial stock price \$40.75. In this case, investors receive the principal plus any unpaid coupons. At maturity, the notes convert into shares of the reference security-0.25 share of JPMorgan's stock in this case—if the market value of the reference stock at the note's maturity is below the trigger price \$32.60 (80% of the reference asset on November 27, 2012). Otherwise, investors will receive the \$10 face value.

Valuation

This note can be viewed as a combination of a zero-coupon note from UBS, a series of contingent coupon payments, and a short put option on the reference asset. For reasonable valuation inputs this note was worth \$9.65 per \$10 face value when it was issued on November 30, 2012, including \$9.94 for the present value of the zero-coupon note, (\$0.69) for the short put options, and \$0.40 for the present value of all future contingent coupon payments.

There is no active secondary market for most structured products. Structured products, including this note, therefore are much less liquid than simple stocks, bonds, notes and mutual funds. Investors are likely to receive less than the structured product's estimated market value if they try to sell the structured product prior to maturity. Our valuations do not incorporate this relative lack of liquidity and therefore should be considered an upper bound on the value of the structured product.

Payoff Curve at Maturity



The payoff diagram shows the final payoff of this note given JPMorgan's stock price (horizontal axis). For comparison, the dashed line shows the payoff if you invested in JPMorgan's stock directly.



Maturity Payoff Diagram




The contingent payoffs of this Trigger Phoenix Autocallable Optimization Security.

Analysis

The 9.42% coupon rate on this Trigger Phoenix Autocallable Optimization Security is higher than those paid by UBS on its straight debts but, in addition to UBS's credit risk, investors bear the risk that, 1) the note may be called; 2) the note may pay zero coupon because of the coupon contingency; 3) and the note will be converted into shares of JPMorgan's stock when JPMorgan's stock is worth substantially less than the face value of the note.


Investors purchasing these autocallable phoenix notes effectively sell contingent put options to UBS and post the note's issue price as collateral to secure satisfaction of the investors' obligations under the option contracts. UBS pays investors a contingent coupon that is part payment for the put options and part interest on the investors' posted collateral. This Trigger Phoenix Autocallable Optimization Security is fairly priced if and only if the difference between the contingent coupon and interest paid on UBS's straight debt equals the value of the contingent put options investors are giving to UBS. Whether this Trigger Phoenix Autocallable Optimization Security is suitable or not is identically equivalent to whether selling put options on the reference stock at the option premium being paid by UBS was suitable for the investor.

UBS's Stock Price





The graph above shows the adjusted closing price of the issuer UBS for the past several years. The stock price of the issuer is an indication of the financial strength of UBS. The adjusted price shown above incorporates any stock split, reverse stock split, etc.





Credit default swap (CDS) rates are the market price that investors require to bear credit risk of an issuer such as UBS. CDS rates are usually given in basis points (bps). One basis point equals 0.01%. Higher CDS rates reflect bigher perceived credit risk, bigher required yields, and therefore lower market value of UBS's debt, including outstanding Trigger Phoenix Autocallable Optimization Security. Fluctuations in UBS's CDS rate impact the market value of the notes in the secondary market.






The graph above shows the historical levels of JPM organ's stock for the past several years. The final payoff of this note is determined by JPM organ's stock price at maturity. Higher fluctuations in JPM organ's stock price correspond to a greater uncertainty in the final payout of this Trigger Phoenix Autocallable Optimization Security.

Realized Payoff



Reference Asset JPMorgan's Stock's Implied Volatility



The annualized implied volatility of JPMorgan's stock on November 27, 2012 was 28.04%, meaning that options contracts on JPMorgan's stock were trading at prices that reflect an expected annual volatility of 28.04%. The higher the implied volatility, the larger the expected fluctuations of JPMorgan's stock price and of the Note's market value during the life of the Notes.

Decomposition of this Trigger Phoenix Autocallable Optimization Security



This note can be decomposed into different components, and each component can be valued separately. The chart above shows the value of each component of this Trigger Phoenix Autocall-able Optimization Security.

- Delta measures the sensitivity of the price of the note to the JPMorgan's stock price on November 27, 2012.
 CDS rates can be considered a measure of the probability that an issuer will default over a certain period of time and the likely loss given a default. The lower the CDS rate, the lower the default probability. CDS rate is given in basis points (1 basis point equals 0.01%), and is considered as a market premium, on top of the risk-free rate, that investors require to insure against a potential default.
 Fair price evaluation is based on the Black-Scholes model of the JPMorgan's stock on November 27, 2012.
 Calculated payout at maturity is only an approximation, and may differ from actual payouts at maturity.
