Trigger Phoenix Autocallable Optimization Securities linked to Fortinet Inc

Description

UBS issued \$105,000 of Trigger Phoenix Autocallable Optimization Securities linked to Fortinet Inc on December 10, 2013 at \$10 per note.


These 12-month notes are UBS-branded reverse convertible notes. On the quarterly coupon observation date, if the notes are not called back, they pay either quarterly coupon at an annualized rate of 14.55% if Fortinet Inc's stock price closes above the coupon barrier \$12.35, or no coupon if the stock price closes below the barrier. The first coupon observation date is March 5, 2014. This autocallable notes will be called back if the reference stock price \$17.64. In this case, investors receive the principal plus any unpaid coupons. At maturity, the notes convert into shares of the reference stock at the note's maturity is below the trigger price \$12.35 (70% of the reference asset on December 5, 2013). Otherwise, investors will receive the \$10 face value.

Valuation

This note can be viewed as a combination of a zero-coupon note from UBS, a series of contingent coupon payments, and a short put option on the reference asset. For reasonable valuation inputs this note was worth \$9.56 per \$10 face value when it was issued on December 10, 2013, including \$9.92 for the present value of the zero-coupon note, (\$0.98) for the short put options, and \$0.62 for the present value of all future contingent coupon payments.

There is no active secondary market for most structured products. Structured products, including this note, therefore are much less liquid than simple stocks, bonds, notes and mutual funds. Investors are likely to receive less than the structured product's estimated market value if they try to sell the structured product prior to maturity. Our valuations do not incorporate this relative lack of liquidity and therefore should be considered an upper bound on the value of the structured product.

Payoff Curve at Maturity



The payoff diagram shows the final payoff of this note given Fortinet Inc's stock price (horizontal axis). For comparison, the dashed line shows the payoff if you invested in Fortinet Inc's stock directly.



Analysis

The 14.55% coupon rate on this Trigger Phoenix Autocallable Optimization Security is higher than those paid by UBS on its straight debts but, in addition to UBS's credit risk, investors bear the risk that, 1) the note may be called; 2) the note may pay zero coupon because of the coupon contingency; 3) and the note will be converted into shares of Fortinet Inc's stock when Fortinet Inc's stock is worth substantially less than the face value of the note.


Investors purchasing these autocallable phoenix notes effectively sell contingent put options to UBS and post the note's issue price as collateral to secure satisfaction of the investors' obligations under the option contracts. UBS pays investors a contingent coupon that is part payment for the put options and part interest on the investors' posted collateral. This Trigger Phoenix Autocallable Optimization Security is fairly priced if and only if the difference between the contingent coupon and interest paid on UBS's straight debt equals the value of the contingent put options investors are giving to UBS. Whether this Trigger Phoenix Autocallable Optimization Security is suitable or not is identically equivalent to whether selling put options on the reference stock at the option premium being paid by UBS was suitable for the investor.

UBS's Stock Price




The graph above shows the adjusted closing price of the issuer UBS for the past several years. The stock price of the issuer is an indication of the financial strength of UBS. The adjusted price shown above incorporates any stock split, reverse stock split, etc.





Credit default swap (CDS) rates are the market price that investors require to bear credit risk of an issuer such as UBS. CDS rates are usually given in basis points (bps). One basis point equals 0.01%. Higher CDS rates reflect bigher perceived credit risk, bigher required yields, and therefore lower market value of UBS's debt, including outstanding Trigger Phoenix Autocallable Optimization Security. Fluctuations in UBS's CDS rate impact the market value of the notes in the secondary market.




Fortinet Inc's Stock Price

The graph above shows the bistorical levels of Fortinet Inc's stock for the past several years. The final payoff of this note is determined by Fortinet Inc's stock price at maturity. Higher fluctuations in Fortinet Inc's stock price correspond to a greater uncertainty in the final payout of this Trigger Phoenix Autocallable Optimization Security.

Realized Payoff


This product will mature on December 12, 2014.

Reference Asset Fortinet Inc's Stock's Implied Volatility



The annualized implied volatility of Fortinet Inc's stock on December 5, 2013 was 44.91%, meaning that options contracts on Fortinet Inc's stock were trading at prices that reflect an expected annual volatility of 44.91%. The bigher the implied volatility, the larger the expected fluctuations of Fortinet Inc's stock price and of the Note's market value during the life of the Notes.

Decomposition of this Trigger Phoenix Autocallable Optimization Security



This note can be decomposed into different components, and each component can be valued separately. The chart above shows the value of each component of this Trigger Phoenix Autocall-able Optimization Security.

- Delta measures the sensitivity of the price of the note to the Fortinet Inc's stock price on December 5, 2013.
 CDS rates can be considered a measure of the probability that an issuer will default over a certain period of time and the likely loss given a default. The lower the CDS rate, the lower the default probability. CDS rate is given in basis points (1 basis point equals 0.01%), and is considered as a market premium, on top of the risk-free rate, that investors require to insure against a potential default.
 Fair price evaluation is based on the Black-Scholes model of the Fortinet Inc's stock on December 5, 2013.
 Calculated payout at maturity is only an approximation, and may differ from actual payouts at maturity.
